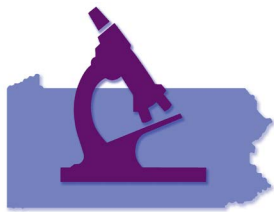

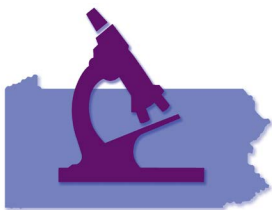

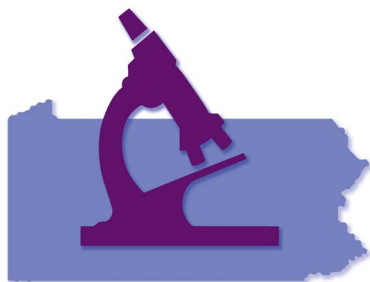

The Pennsylvania Association of Pathologists (PAP) is the only statewide specialty medical society consisting of pathologists and representing pathologists. PAP works to represent and inform Pennsylvania pathologists on issues affecting practices. 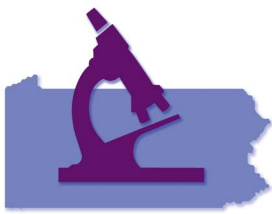

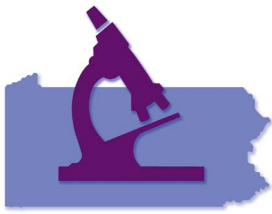

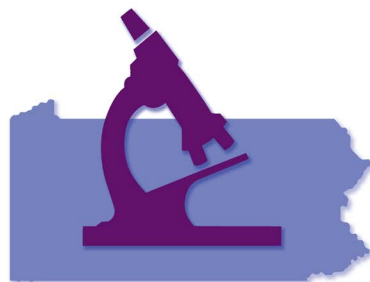
